



2025 Metro Junior West History Day Contest **RESULTS**

This event was one of 12 Regional/District History Day contests in Minnesota, part of the larger National History Day contest cycle. Entries were selected to advance from this contest to State History Day. From there, entries will be selected to compete at the National Contest at the University of Maryland in June.

- State Qualifiers: State Qualifiers are eligible to compete at State History Day on Sunday, April 27 at the Minneapolis Convention Center. Each State Qualifier entry was given a packet of event information and a medal during the Regional awards ceremony. State registration is due Thursday, April 10 by 7:59 pm. Each State Qualifier entry must register for State. If you did not get the entry packet or medal, please contact the event coordinator. State Qualifiers are not ranked.
- Honorable Mentions: Honorable Mention can be awarded by the judges for a variety of reasons related to excellence in the project or the process of creating the entry. Honorable Mention entries receive a ribbon. Honorable Mentions are **not** runners up to State Qualifiers and are not ranked.

Frequently Asked Questions about Regional Results

If a State Qualifier entry can't compete at State, can an Honorable Mention entry take their place?

No. Honorable Mention entries are not runners-up to State and are not ranked. If a State Qualifier entry cannot compete, no other entry replaces it..

If I am a State Qualifier, do I have to register for the State contest?

Yes. State Qualifier entries must register for the contest if they intend to compete. Online registration is due Thursday, April 10 at 7:59 p.m.

I was not at the Awards Ceremony and am missing my packet or a medal/ribbon. What should I do?

Contact the Regional event coordinator, listed on the Regional event page.

When will I get my comment forms from judges?

Comment forms will be returned to the lead teacher at the school via postal mail within one week of the Regional contest. If judges submitted comments online, students will be able to access these within one week of the contest directly in zFairs.

Where can I find pictures from the Regional contest?

Pictures from the contest are on the Minnesota History Day Flickr page.

Can I change my entry between Regionals and State?

Yes. Students are allowed and encouraged to use the feedback from judges, others, and their own ideas to make changes between contests.

Why does the number of State Qualifier entries vary between Regional contests and categories?

The number of State Qualifier entries varies based on the total number of school-level participants feeding into the Regional contest. Some Regionals have far more school-level entries than others, even if the event itself is not larger. Events representing a larger school-level participation will be able to send more to State. Learn more about <u>the allotment process</u>.

How were the entries judged?

Entries are judged based on the *National History Day Contest Rule Book*, which is <u>available online</u>. The same criteria are used at all levels of competition. In general, the weight of the criteria is as follows:

- 80% Historical Quality
- 20% Clarity of Presentation
- Rules Compliance

Who were the judges?

Judges are volunteers with an interest in history, education, and working with young people. They come from libraries, historical societies, colleges/universities, and other cultural and business organizations in Minnesota. Many of our judges have participated for multiple years and each judge receives training in advance of the event.

What if I have a concern about judging?

"Judges must evaluate certain aspects of your entry that are objective (e.g., whether primary sources are used or whether the written material is grammatically correct and accurately spelled). Judges also must evaluate aspects of your entry that are subjective (e.g., analysis and conclusions about the historical data). Historians often reach different opinions about the significance of the same data. It is therefore crucial for you to base your interpretations and conclusions on solid research and to present your work well in your project and written materials."
